- 3. Consider and act upon the Minutes of previous meeting(s). After review, Jerry Rhodes made a motion, seconded by Matt Goodwin, to approve the July 18, 2023, meeting minutes as written. A vote was taken, the motion passed 5-0.
- 4. Consider and act to accept the July 2023 financials. After review, Bill Hart made a motion, seconded by Tim Stewart, to accept the July 2023 financials as presented. A vote was taken motion passed 5-0.
- 5. Engineer Report.
 - (a) Working on TXDOT expansions of FM 1641 and FM 741.
 - (b) The plans for the vault for Pump Station #3 needed a few changes. Changes have been made and we are waiting for NTMWD approval.
- 6. Attorney Report.
 - (a) Crandall Contract amendment is in the process of being completed.
 - (b) Reviewing TXDOT bid for acreage at 12475 Windy Lane.
- 7. Discuss and consider Approval of Non-Standard Water Utility Service Contact Between Talty Special Utility District and USEF East Gate II, LLC. After review Scot Boisvert made a motion, seconded by Matt Goodwin, to approve the Non-Standard Water Utility Service Contract with USEF East Gate II, LLC. A vote was taken motion passed 5-0.

- 8. Discuss and consider approval and awarding of bid for the construction of Pump Station #3 Pump Building. After review Scot Boisvert made a motion, seconded by Tim Stewart to award the Pump Station #3 bid to Felix Construction for \$5,668,500.00. A vote was taken motion passed 4-0 with 1 abstaining.
- 9. Discuss and consider Texas Department of Transportation (TXDOT) offer for condemnation of 0.2825 acres of district property at 12475 Windy Lane, Forney, Texas. After review Bill Hart made a motion, seconded by Jerry Rhodes to give approval for Kristen Francher and Corey Trail to work on a counteroffer to TXDOT. A vote was taken motion passed 5-0.
- 10. Monthly Operations Reports from General Manager, Field Supervisor and Office Manager.
 - (a) Preliminary annual budget Is done working on a final budget that will need to be approved by September 30, 2023.
 - (b) Tank inspections will be done next week.
 - (c) Billed out Las Lomas Phase 1 & 2 connection fees at approximately \$600,000.

 - (f) Replaced Pump at Pump Station #2, two more pumps will be sent out to be rebuilt.
 - (g) Turned off East Gate I & II for non-payment currently they owe \$157,293.00
